



# 2023 Corinthian Spring Series

March 25, April 8, April 22, May 13

## Notice of Race

### 1. RULES

- 1.1. The race will be governed by the rules as defined in *The Racing Rules of Sailing*. The Organizing Authority is the Corinthian Yacht Club of San Francisco.
- 1.2. RRS 40.1 will apply requiring competitors to wear Personal Flotation Devices.
- 1.3. One Design class rules are in effect where sufficient boats are registered to form a One Design fleet.
- 1.4. Power assisted winches are permitted if disclosed and included in a boat's PHRF rating. This modifies RRS 52.
- 1.5. Nothing in these rules shall be construed to relieve any participant from their duty to comply with health requirements.

### 2. ELIGIBILITY AND ENTRY

- 2.1. Eligible boats shall enter by completing the online entry form at: <https://race.cyc.org/spring23>
- 2.2. One entry per boat will be accepted.
- 2.3. Entries must be received by 1200hrs March 23, 2023
- 2.4. Entries submitted after 1200hrs March 23 may be permitted at the discretion of the race organizer.
- 2.5. All participating boats should have a valid 2023 BAMA or NCPHRF certificate. The race committee may, at its discretion, waive the ratings certificate and/or, assign ratings to boats provisionally or finally where (a) YRA has not delivered an applied-for rating or (b) racing one-design or (c) racing non-spinnaker.

2.6. Fleets will be defined based on entry registration and may include Multi-hull, PHRF, Non-Spinnaker, One Design and Sportboat. A fleet with five or fewer boats may be merged with another fleet or declined. BAMA and PHRF fleets will not be merged. Final fleet assignments will be set out in the sailing instructions.

- **BAMA and PHRF fleets** may be grouped primarily based on their relevant assigned rating.
- **One Design fleets** are formed when five or more entries of that class are registered and will subject to their respective One Design class rules. One Design classes with six or more entrants, may have a separate start.
- **Non-Spinnaker Fleet** is for boats rated with spinnakers but racing without them, and specified other boats, if accepted by the Race Committee. IOD's, Wyliecats and other cat boats shall race in the Spinnaker division. All boats in the Non-Spinnaker divisions are subject to ratings modification by the Race Committees at its discretion.

### 3. FEES

3.1. The entry fee for the entire regatta will be \$145 for each boat.

3.2. The entry fee includes the entry to the SYC *Jaws Pursuit* race.

### 4. SCHEDULE OF EVENTS

4.1. Four races are scheduled in the regatta, with one race each day.  
March 25, April 8, April 22 and May 13.

4.2. The race on March 25 will be the *Jaws Pursuit* race organized by Sausalito Yacht Club. Event information

4.3. The warning signal for March 25 is specified in the SYC race documents.

4.4. First Warning Signal is scheduled at 1230hrs for Races on April 8, April 22 and May 13.

### 5. SAILING INSTRUCTIONS

Sailing Instructions will be available no later than March 23, 2023 by 2000hrs on the web site at: <https://race.cyc.org/spring 23>

## **6. VENUE & COURSES**

The series will take place entirely within San Francisco Bay. Courses will be defined in the Sailing Instructions.

## **7. SCORING**

7.1. Handicapped divisions will be scored time-on-time for fleet races and time-on-distance for pursuit races.

7.2. One race must be completed to constitute a series. There will be no throw-outs.

7.3. The scoring for the March 25 race will be calculated using the results of the *Jaws Pursuit* race.

## **8. RADIO COMMUNICATIONS**

The Race Committee may make radio transmissions to communicate information about time to start and recalls.

## **9. PRIZES**

Series trophies will be presented at the CYC Clubhouse following the event.

## **10. INSURANCE**

Each participating boat shall be insured with valid third-party insurance.
